

This document describes the operation and characteristics of the Industrial Folding Funnel IFF (hereinafter "funnel"). It contains important information about how to use the funnels properly and how to increase their reliability and life. This document must always be available in the place where the funnels are used. Keep it together with the funnels at all times. The operator is responsible for using the funnels safely and in compliance with the instructions in this manual, which applies to any third persons as well. If you have any doubts about the correct use of the funnels, please contact the manufacturer or an authorized dealer.

Industrial Folding Funnel IFF serves for capturing small drips in hard-to-reach places, or at heights (cracked pipes, etc.). They can be used alone or hung on special height-adjustable stands. Attaching the funnel to the hooks in the corners of the stand is quick and easy.




## Specification of types of Industrial Folding Funnels IFF

Funnels IFF are produced in 2 basic sizes – volume 10 or 140 litres – see the table below. It is possible to purchase a special height-adjustable folding stand for the larger funnel, which is used to hang the funnel – see additional accessories on page 5.

## **General information**



When using the funnels, observe these instructions as well as all the safety notices herein.

- Funnels are used to catch escaping hazardous substances in hard-to-reach places, such as cracked pipes, etc.
- 2. Funnels IFF are produced in 2 basic volumes 10 and 140 litres.
- If necessary, the large funnel can be hung on a special height-adjustable stand – see optional accessories, page 5.
- 4. The funnels have 4 handles in the corners for easy handling or hanging at height.
- 5. The funnels are made of a chemically resistant

material – PVC with a protective proofing layer (PES/PVC 680 g/m<sup>2</sup>) – see Chemical resistance certificate, p. 7.


- 6. The funnels are not intended for long-term storage of aggressive substances.
- 7. The range of temperatures for the use of the funnels is from -30 °C to +70 °C.
- 8. The funnels are supplied with a C52 or D25 coupling as standard.
- 9. The bag is not a standard part of the product.

# Instructions for putting the funnel into the ready-to-use position



Remove the funnel and any accessories from the transport bags. Secure the funnel with the handles in the corners under the leaking liquid. You can also hang the funnel on a height-adjustable stand if necessary. The coupling is used to attach the fire hose, which conducts the trapped liquid into a collection container.

## Handling instructions and safety warnings

- 1. Do not put the product near fire or any other sources of heat.
- 2. The range of temperatures for the use of the funnels is from -30  $^{\circ}$ C to +70  $^{\circ}$ C.
- 3. The funnels are resistant to a large number of different liquids and loose materials (see the Chemical resistance certificate, p. 7).
- 4. The funnels are not intended for long-term storage of aggressive substances.
- 5. After each use it is necessary to wash the funnel thoroughly, clean it with suitable detergents and let it dry completely.
- 6. Observe the safety measures for working with hazardous liquids and with substances harmful to the environment.
- 7. Make sure you observe any necessary precautions regarding personal safety, such as the use of protective equipment.

#### **Recommended optional accessories**

A C52 or D25 fire hose coupling is a standard part of every funnel. In addition to the large funnel, a heightadjustable folding stand can be ordered. It is also possible to purchase the above-standard accessories for the funnels at an additional cost.

### Maintenance and storage

After the draining and prescribed environment-friendly disposal of the collected substance, the product must be washed with proper neutralization detergent (in the case of aggressive substances) and lukewarm water or another suitable detergent. We recommend storing the funnels folded in the carrying bag so that they are not damaged while not in use. The funnel must be dried thoroughly before it is put into the bag. For long-term storage, place the funnel in a dry place out of the reach of UV radiation.

If you want to request repair, order accessories or lodge a complaint, please, contact your qualified supplier.

#### Warranty conditions

The warranty period is indicated in the warranty certificate on the last page of these Instructions for use. The warranty period is 24 months and begins on the day indicated in the warranty certificate. The warranty does not apply to the normal wear and tear or to damage caused by improper use or by the instructions in this manual not being observed.
