




This document describes the operation and characteristics of the ET COOL-EL Cooling Container (hereinafter "container"). It contains important information about how to use the container properly and how to increase its reliability and life. This document must always be available in the place where the container is used. Keep it together with the container at all times. The operator is responsible for using the container safely and in compliance with the instructions in this manual, which applies to any third persons as well. If you have any doubts about the correct use of the container, please contact the manufacturer or an authorized dealer.

The foldable ET COOL-EL Cooling Container is, in its construction and dimensions, specially developed for quenching and cooling electric cars and hybrid cars by flooding them with water for the necessary time. Cooling the lower part of the car, where the traction batteries are located, reliably prevents the car's battery from re-igniting and causing another fire.

# General information 💴



When using the containers, observe these instructions as well as all the safety notices herein.

- 1. Containers are designed as a quick solution for emergency situations. They are used exclusively for quenching and cooling electric cars and hybrid cars by flooding them with water for the necessary time.
- 2. Containers are self-supporting, reinforced around the perimeter with collapsible side supports.
- 3. The containers do not have welded corners, which allows to unfold and refold any of the sides for the possibility of simply and guickly pushing the damaged vehicle into the container space.
- 4. The container can be laid out on a flat surface and conveniently washed.
- 5. Containers are made of chemically resistant selfextinguishing material – PVC with a special surface treatment (PES/PVC 900 g/m<sup>2</sup>) - see Chemical resistance certificate, page 10.


- 6. The temperature range of using the container is -30 °C to +70 °C.
- 7. Containers are supplied in transport packaging as standard.
- 8. When using the containers, it is necessary to use the supplied standard accessories: protective pad and an inner pad – page 8. Both significantly extend the durability and service life of the container.
- 9. The container can be produced in a size according to the customer's wishes.
- 10. The container can be equipped with a ball valve on request.


# Instructions for assembling the container into the standby position




Remove the container, protective pad, inner pad and side supports from the transport packaging. Spread the protective pad on a flat surface. Spread the unfolded container on the pad. For the entire area on the bottom of the container, place the inner pad so that it extends over the short folded side of the container on one side. Choose the side of the container through which you will push the damaged car into the container space. Raise the sides and secure the corners with the yellow hooks to build the container. Leave the shorter side of the container pad open. The raised sides of the container must now be reinforced with side supports, which are anchored by means of black straps located under the bottom of the container and small black grips at the top of the container. The lower black straps must be hooked into the lower part of the supports and the upper part of the support must be secured to the handle at the upper edge of the container is thus prepared for pushing the damaged electric car into the container space. After placing the car into the container, build the last side of the container – secure the side with yellow hooks and place the side supports.

#### Illustrated instructions for assembling a collapsible container ET COOL-EL








## Handling instructions and safety warnings

- 1. If possible, place the collapsible container on a flat surface.
- 2. Make sure there are no sharp objects under the container, such as pieces of broken glass, nails, sharp stones, etc., which might mechanically damage its bottom.
- 3. Do not put the product near fire or any other sources of heat.
- 4. The temperature range of using the container is  $-30 \degree$ C to  $+70 \degree$ C.
- 5. The containers are resistant to a large number of different liquids and loose materials (see the Chemical resistance certificate, p. 10).
- 6. Fill the container up only to the upper weld of the reinforcement.
- 7. Do not move or pull an empty or a filled container on the ground the manufacturer's warranty does not cover mechanical damage.
- 8. Side handles located around the container are used to move the container.
- 9. After each use it is necessary to wash the container thoroughly, clean it with suitable detergents and let it dry completely.
- 10. Observe the safety measures for working with hazardous liquids and with substances harmful to the environment.
- 11. Make sure you observe any necessary precautions regarding personal safety, such as the use of protective equipment.

## Maintenance and storage

After the draining and prescribed environment-friendly disposal of the collected substance, the product must be washed with proper neutralization detergent (in the case of aggressive substances) and lukewarm water or another suitable detergent. We recommend storing the containers folded in the carrying bag so that they are not damaged while not in use. The container must be dried thoroughly before it is put into the bag. For longterm storage, place the container in a dry place out of the reach of UV radiation.
